Subject:- Transfers and postings of officers of Rural Dev.Deptt.

In the interest of Administration, the following postings/adjustments and transfers of the officers of Rural Development Department are hereby ordered with immediate effect:-

1. Shri Raman Kesar I/C DPO Rajouri is transferred and posted as I/C Project Officer, DPAP Udhampur purely as stop gap arrangement in his own pay and grade.
2. Shri P.S.Rathore I/C DPO under orders of transfer as I/C DPO Kargil, is adjusted as I/C Project Officer Watershed Rajouri in his own pay and grade purely as stop gap arrangement.
3. Shri Vikas Sharma I/C DPO Jammu is posted as I/C Project Officer Self Employment DRDA Jammu in his own pay and grade purely as stop gap arrangement.
4. Smt.Indu Kanwal I/C DPO Samba is transferred and posted as I/C DPO Jammu.
5. Shri Sudershan Kumar BDO Khour is transferred and posted as I/C DPO Samba in his own pay and grade.
6. Shri Mohinder Singh I/C DPO(Publicity) Kishtwar is transferred and posted as I/C Project Officer DPAP Doda in his own pay and grade purely as a stop gap arrangement against an available post.
7. Shri Kalyan Singh BDO awaiting orders of posting is adjusted as I/C DPO Kishtwar in place of Shri Mohinder Singh.
8. Shri Mohd.Nazir Sheikh I/C Project Officer Watershed Poonch is transferred and posted as I/C DPO Rajouri. The charge of post of PO Watershed Poonch shall be held by DPO Poonch till further orders.
9. Shri Ashok Kumar I/C PO Watershed Rajouri is transferred and posted as I/C DPO Kargil in his own pay and grade.
10. Shri A.K.Wali I/C BDO presently posted in DPMS Jammu shall hold the additional charge of BDO Khour in addition to his own duties till further orders.
11. Mtr.Abida Panjoo LPO shall lookafter the post of BDO (HQ) Srinagar in her own pay and grade purely as a stop gap arrangement. She shall, however, remain headquartered in the Directorate of Rural Dev. Kashmir and attend the work that may be assigned to her by the DRDK from time to time.
12. Shri Prabh Dayal under orders of transfers as I/C BDO (HQ) Udhampur is posted in Block Nyoma against an available vacancy.
13. Shri Syed Zahoor Safvi ADO Machil is transferred and posted as I/C BDO Drass in place of Shri Mohd.Sidiq. The work of ADO Machill shall be looked after by BDO

Additional Block Kalaroos in addition to his own duties till further orders.

14. Shri Mohd.Sidiq I/C BDO Drass is transferred and posted in Block Shaker-chiktan against an available vacancy.

19. Smt.Tripta Sharma, Mukhya Sevika, is posted as I/C BDO (HQ) Udhampur in her own pay and grade purely as stop gap arrangement.
20. Smt.Kundan Beer, Mukhya Sevika, is posted as I/C BDO Block Rafiabad in her own pay and grade purely as stop gap arrangement against an available vacancy.

The officers placed against higher posts shall, however, have no claim to hold the posts on substantive basis which shall be filled strictly in accordance with the rules by the competent authority. They shall also retain lien and seniority on their parent cadre.
