2. The DDCs (Chairman DRDA) shall ensure the submission of utilization certificate (current as well as pending if any) to the Administrative Department/ Accountant general J&K.
3. The monthly progress report both physically and financial shall be submitted to the Administrative Department/Accountant general on monthly basis to vouchsafe the expenditure.

4. The funds shall not be kept in the saving Bank account without proper authorization from the Administrative Department.
5. The implementing Agencies shall ensure that the expenditure is debited to the following Account Head of the Programme:-
