Subject: Revised Wage Rate for Un-skilled manual Workers under MGNREGA.

Ministry of Rural Development, Government of India has vide Notification S.O. 82 (E) dated, 14<sup>th</sup> January 2011 issued in exercise of power conferred by sub-section (1) of Section 6 of MGNREGA 2005 (42 of 2005), and in suppression of the notification of Government of India in the Ministry of Rural Development number S.O. 1 (E), dated the 1<sup>st</sup> January, 2009, except as respects things done or omitted to be done before such supersession, specified the wage rate payable to the unskilled manual workers in respect of State of Jammu & Kashmir as Rs 121.00 per day w.e.f 1st January 2011.

All District Programme Coordinators, Ex. Engineers, Programme Officers, AEEs/ AEs/JEs and other officers /officials of Rural Development Department through this circular are advised to ensure all unskilled manual workers are paid at the revised Rate of Rs 121.00 w.e.f 1st January 2011 strictly as per revised notification of the Government of India (Copy enclosed). Revision of estimates shall be accordingly made on all ongoing or new works which have bearing w.e.f 1st January 2011 without any delay. Labour Budget for the year 2011-12 shall be accordingly revised.
