Subject: Works on individual land under Mahatma Gandhi NREGA.

In terms of the Mahatma Gandhi National Rural Employment Guarantee Act, the adult members of every household who –(i) reside in any rural areas; and (ii) are willing to do unskilled manual work may submit their names age and the address of the household to the Halqa Panchayat at the village level (Halqa Panchayat) in the jurisdiction of which they reside for registration of their household for issuance of a job card.

02. It is made clear that the right to work is linked with the place of residence and not with the place where the individual beneficiary has land of his own. The following conditions are stipulated to be fulfilled:-

- (a) The individual land owner shall be a job card holder and also work in the project
- (b) For each such project the labour material ratio of 60:40 shall be maintained at the Halqa panchayat level
- (c) Projects shall be approved by the Halqa Majlis and the Halqa Panchayat and shall be part of the annual shelf of projects
- (d) No contractors or machinery shall be used for the execution of work and
- (e) No machinery shall be purchased.

03. Hence the benefits of facilities provided in Para 1(iv) of Schedule I of the Mahatma Gandhi NREG Act may not be availed of by individual beneficiaries having their own lands in other Halqa Panchayats.

04. This may be noted for guidance & compliance.


