Sanction is hereby accorded to the release of Rs 436.503 lacs (Rupees four Crores, thirty six lacs, fifty thousands and three hundred) only under Development Grants of BRGF as revalidated by the Finance Department in favour of District Development Commissioner Kupwara, Poonch, Doda, Ramban and Kishtwar as per break up given below for its further placement at the disposal of concerned Sectoral Officers/Implementing Agencies for the completion of ongoing works taken up against the approved action plan of 2008-09 and its utilization during the current financial year (2010-11). The revalidation of funds is subject to the following conditions:-

1. The implementing Agencies shall indicate in their sanction order the component- wise break-up of the funds to be utilized with a copy to the Rural Development Department for information and record.
2. The funds shall be utilized for execution of the scheme strictly as per organically approved components and according to GOI's prescribed guidelines.
3. All Codal formalities viz accord of Administrative approval, Technical Sanctions etc. shall be observed by the Executiing Agencies.
4. Monthly Progress Reports both physical and financial shall be submitted on regular basis to the Rural Development Department for monitoring of expenditure besides, ensuring the utilization as early as possible and definitely well before 31-03-2010 to GOI with a copy to the administrative Department.
5. FA/CAO of the Department shall vouch safe the utilization of funds as per codal procedures/GOI guidelines.
6. It may be ensured that the expenditure is booked as per the following classification for proper accounting:-
