Subject: **Placement of Incharge Assistant Engineers as Incharge Assistant Executive Engineers(REW).**

Sanction is hereby accorded to the temporary placement of following Assistant Engineers(Diploma Holders) borne on the cadre of Rural Engineering Wing of Rural Development Department as Incharge Assistant Executive Engineers on officiating basis in their own pay and grade for a period of six months or till the posts are filled up on regular basis through DPC/PSC, whichever is earlier:

The above placements are made on stop gap basis purely in the interest of administration and shall not confer any preferential claim upon them for regular promotion, which shall be made as per rules. These placements shall be further subject to clearance with regard to work and conduct/Integrity and Vigilance and without prejudice to the finalization of tentative seniority list as also without the outcome of writ petition pending, if any, before the Court of Law. ✓

These placements shall be liable to reversion as and when eligible officers from the relevant source of appointment i.e. Degree Holders become available to fill up these vacancies earmarked for them but utilized for Diploma Holders due to non-availability of required number of Degree Holders.



Consequent upon the above, following transfers/adjustments of Incharge Assistant Executive Engineers are made as under:-

- 1- Shri Assadullah Malik on his placement as Incharge Assistant Executive Engineer is posted in REW Sub-Division Quimoh+Kulgam against available vacancy.

The posting orders in respect of Shri Ghulam Rasool on his placement as In-charge Assistant Executive Engineer shall be issued separately.


The jurisdiction of newly created posts shall be defined separately.


