Sanction is hereby accorded to the release of funds to the tune of Rs. 18,00 lacs (Rupees eighteen lacs) only alongwith its advance drawal in favour of Director Rural Development Jammu for its further placement at the disposal of General Manager/ CEO, Divisional Procurement Supply and Marketing Society Jammu under DRDA Scheme (Revenue Component) for salary purposes of the staff of the society.

The release / Advance drawal of funds is subject to the following conditions:-

1. that the CEO/General Manager of the said society shall ensure budget estimates in B4(I) and B4(II) of the sanctioned staff and actual requirement for the current financial year under the object head salary component of the said society and furnish to this office in the first instance before incurring expenditure.
2. Detailed account in support of advance drawal are sent to the Principal Accountant General J&K along with a certificate to the fact that the accounts of all the previous accounts shall be furnished to the Accountant General.
3. the funds are utilized strictly as per the guidelines of DRDA Scheme for committed items of expenditure and the amount is utilized during the first six months of the current financial year on salary component only after observing all codal formalities.
4. the expenditure shall be debited to the appropriate head of account and six tier classification is properly recorded and agency shall ensure timely submission of accounts to the Accountant General/Administrative Department current as well as previous (Pending if any).
5. monthly progress report both physically and financial shall be submitted on regular basis to the Administrative Department for monitoring of expenditure.
6. The funds authorized shall not be kept in any saving Bank Account without proper authorization of the Administrative Department.
7. the advance drawal is subject to the fulfillment of the conditions enumerated above
