- 3) there shall not be any duplicacy in adoption of works/Incurring of expenditure.
- 4) the progress report shall be submitted to the Administrative Department latest by 5<sup>th</sup> of each succeeding month to ensure monitoring of expenditure n oversee its implementation over the year.
- 5) the expenditure shall be debited to the appropriate account Head of CD & Panchayat ( State Plan).


