3. There shall not be any duplicacy in adoption of works while incurring expenditure.
4. The advance drawal is also subject to the condition that accounts/ utilization Certificates of previous advance will be submitted at an earlies to the concerned quarters and Administrative Department by the implementing agencies besides ensuring reply of the quaries sought vide this office letter No. RD/PC/31/2009-10 dated 14-09-2010 followed by reminder dated 09-12-2010
5. The physical/ Financial progress report shall be summtted to the Administrative Departmetn lates by 5th of each succeeding month.
6. The expenditure shall be debited to the appropriate account head od CD and Panchayat Sector(State Sector plan funds 2010-11)
