Subject:- Annual Plan 2010-11 - release of funds under CD and Panchayat Sector.

Government Order No. 57 -RD of 2011

Sanction is hereby accorded to the release of funds to the tune of Rs 48.00 lacs (Rupees forty eight lacs) only under CD and Panchayat Sector in favour of Director Rural Development, Jammu for its further placement at the disposal of Assistant Commissioners Development concerned for utilization of funds against the works enclosed as Annexure "A" during the current financial year (2010-11).

The releases of funds are subject to the following conditions:-

1. The funds so released shall be utilized for the purpose for which these are released.
2. All codal formalities shall be observed while incurring of expenditure to observe financial discipline.
3. There shall not be any duplicacy in adoption of works/ incurring of expenditure.
4. The implementing agencies shall ensure that the works are executed only in rural areas and also keeping in view the spirit of Govt. Order No. 117-RD of 2008 dated 03-04-2008.
5. The works are completed within the released amount and estimates are firmed up accordingly.
6. The expenditure shall be debited to the appropriate account head of CD and Panchayat.
7. The monthly progress reports both physically and financial shall be submitted on regular basis to Rural Development Department for monitoring of expenditure.
8. The works should strictly be executed as per the instructions conveyed vide Govt. Order No. 55-RD of 2010 dated 27-01-2010.




