Subject:- Contractual engagement of Programme Officers under National Rural Employment Guarantee Act (NREGA).

Consequent upon the selection made by the committee constituted for the purpose, sanction is hereby accorded to the engagement of following candidates as Programme Officers against the Blocks mentioned against each:-

The orders of engagement are subject to the following:-

1. The arrangement shall be operational for a period of one year in the first instance renewable as per the requirement and the performance of the incumbent.
2. The arrangement shall be terminable by one months advance notice from either side.
3. The Programme Officer shall be entitled for TE as admissible to Government Employees of the rank of Block Development Officers in Rural Development Department.
4. A consolidated sum of Rs.15,000/= shall be paid to the Programme Officer in addition to the TE as per admissibility referred here-to-above. The expenditure on account of salary of the appointees during their period of contractual appointment shall be debited to the Administrative expenses of NREGA.
5. The Programme Officer while being on the job shall have to discharge all responsibilities set up for the said assignment under NREGA, J&K Rural Employment Guarantee Scheme and all other circulars, instructions and orders issued from time to time by the State/Central Government.

The contractual appointees shall report to the concerned District Programme Coordinator (ACD) concerned within a period of 21 days subject to the production of following documents:-

1. Academic Qualification Certificate.
2. Matriculation Certificate.
3. State Subject Certificate.
4. Character Certificate.
5. Non-drawal loan Certificate from District Employment Officer.

In case the contractual appointee(s) shall not report for duties within the stipulated period of time, the offer shall automatically stand terminated and next in the panel would be considered for adjustment.

The District Programme Coordinator (ACD) concerned shall provide all logistic support to the contractual appointees and shall submit periodical reports about their progress to the Administrative Department.
