
Sir,

The Adoption of Accounting frame work consistent with Model Accounting System (MAS) and PRIASoft is one of the conditions for claim of Performance Grant component under 13<sup>th</sup> Finance Commission Award for Panchayati Raj Institutions. Ministry of Panchayati Raj Govt. of India vide a communication of dated 21<sup>st</sup> October 2010 has asked for preparing a time bound roll out plan which may include demonstrating the software, building a team of at least three Master trainers in each District, training of relevant functionaries and holding of workshop on PRIASoft in which NIC and Ministry of Panchayat Raj would explain the use of software, the Ministry has further expressed its willingness to provide consultant support in this regard.

Pursuant to above, a decision has been taken in the Rural Development Department that at least two officials ( Master Trainers) will be nominated one from Accounts Side ( AAO/Accountant) and one computer operator working in Rural Development Department for under going training as Model Accounting System / PRIASoft to be imparted by the NIC and representatives of Ministry of Panchayati Raj Govt. of India at Divisional level.

It is as such requested, that the nomination of the above officials may be made available to this Department within a weeks time positively on the proforma annexed herewith.
